LOGIN INSTRUCTIONS:

- ✓ Log on to CUNYfirst at <https://home.cunyfirst.cuny.edu> with your Username and Password you created.
- ✓ Once logged on, *click on HR/Campus Solutions → Self Service → Faculty Center → voe roster.*
- ✓ Click the View Roster icon next to the class you are teaching to submit attendance.

Note: If you are teaching at more than one CUNY institutions and do not see BMCC classes, you may click “Change Term” button and select 2020 Fall Term/Borough of Manhattan CC in order to access your BMCC attendance rosters.

VERIFICATION OF ENROLLMENT INSTRUCTIONS:

You are required to submit completed rosters indicating those students who have never attended any of the classes since the beginning of the term/session nor are otherwise active and participating in the course (e.g. by submitting assignments, attending a required study group, academic conference or tutorial) or academically-related activity.

Academically-related activities include, but are not limited to:

- physically attending a class where there is an opportunity for direct interaction between the instructor and students;
- submitting an academic assignment;
- taking an exam, an interactive tutorial, or computer-assisted instruction;
- attending a study group that is assigned by the school;
- participating in an online discussion about academic matter;
- engaging in an online academically-related activity, or initiating contact with the instructor to ask a question about the academic subject studied in the course or ask a course-related question.

Note: Logging into an online class is not sufficient, by itself, to demonstrate participation in an academically-related activity by the student.

This is to comply with federal financial aid regulations and to assist our students in obtaining their financial aid.
