Course Description:

An introduction to federal tax law as it relates to individuals. Topics covered include gross income, adjusted gross income, deductions, exemptions, credits, taxable income, tax liability, credits, capital gains and losses, depreciation, non-taxable exchanges. Students will examine the Internal Revenue Code and regulations as it relates to the topics covered. Students will also learn to prepare Federal Income Tax form 1040.
